## 3. <u>DEVOTIONAL</u>

The Devotional was given by Allison Trites on the theme" Stronger Together" (Philippians 1:3-11). Using three examples from Acts 16 (Lydia, the soothsaying girl, and the jailor) and two from Philippians (Syntyche and Eudoia, Philippians 4:2), he stressed the importance of Christians working together, forgiving each other, and keeping good relationships with one another.

## **HABITATAT FOR HUMANITY**

David Garrett introduced Edith Menzies from Habitat for Humanity and she addressed the meeting giving some very interesting information about Habitat for Humanity, its goals and its modus operandi. Edith is the Chair of the Selection Committee of the Valley Chapter of H for H. The first dwellings built by Habitat in this area was a duplex built in Wolfville. One part of the duplex is now occupied and the other had to be vacated due to personal reasons on the part of the occupant. A new occupant is being sought. Land has now been purchased in the New Minas area and "build number two" for the Valley is shortly to be underway. Meanwhile, suitable families are being sought. Such families must fit into the income guidelines and be able to perform 500 hours of sweat equity. The latter can be done by a proxy arrangement where the person/persons are unable to perform physical labour themselves. There is no down payment and no interest charged on the loan. Monthly mortgage and tax payments will not exceed 30% of the family's monthly income. Ms Menzies left some literature and was thanked for her most informative presentation.

The venture has received a grant of \$500 for "Active Kids: Healthy Kids". It is hoped that it will be possible to run a pilot at the Wolfville Recreation Centre in May and June and that the Centre will be able to provide one staff person.
